**I. Old Business:**

**A.** The committee approved meeting minutes for the July 3, 2019 Public Safety meeting 3-0.

**II. New Business:**

**A. Cruise Night Event \***

The chief appeared before the committee with an approved special event application for the annual Cruise Night Event to be held on September 14, 2019. The event was approved by a vote of 3-0.

**B. .5 K \***

The chief appeared before the committee with an approved special event application for the annual .5 K event to be held on October 26, 2019. The event was approved by a vote of 3-0.

**C. East fifth Street Stop Sign Relocation**

The chief advised the committee that the PD was working with the borough's traffic engineer to relocate the stop sign on Line Street from the intersection with

East Fifth Street to the intersection with East Fourth Street. This move was made to accommodate the pedestrian crossings at East Fourth and North Line Street

#### **D. Stop the Bleed Event**

The chief advised LPD is working with Abington Hospital to host a community event for first aid entitled "Stop the Bleed" to focus on the triage of persons suffering injuries requiring blood stopping techniques for survival.

#### **E. Sergeant promotions \***

The chief advised the committee of the need to promote two sergeants at the business meeting in August. The vote was 3-0.

### **III. Public Comment**

**Debra Kline-** Related to the committee that the new handicap ram on North Line Street at East fourth Street has water ponding at the base after a heavy storm. Rick Delong from Public work advised this was a common problem with ADA. She also advised the crosswalk on Church Road at Hancock does not align with the ramp. Delong stated he would investigate the issue.

**Anne Scheuring-** Came to PS requesting increased enforcement of the no parking at the corner of Woodland Ave and East Main Street.

**Joe & Sandy Troiani-** Came to PS to talk about vehicles speeding down Lombardy Drive from North Wales Road. A discussion followed from their complaint regarding traffic calming on the street. The chief advised he would speak with the borough traffic engineer regarding traffic calming on Lombardy and other road in the area of North wales Road.
